Receiving a tier designation reflects the high level of respect a firm has earned among other leading lawyers and clients in the same communities and the same practice areas for their abilities, their professionalism and their integrity—and signals a unique combination of quality law practice and breadth of legal expertise.

In August, Deborah Brouwer, co-managing partner of Nemeth Law, and Patricia Nemeth, founder of Nemeth Law, were selected by their peers for inclusion in *The Best Lawyers in America*® 2022.
